Cleaning Hints:

The beauty of aluminum products by Crest is in their ease of maintenance. Pollutant films, caused by auto or local industry emissions, can cause an acid type build-up on the baked enamel painted surface.

This can usually be removed by a periodic cleansing with any household detergent. Mix a few tablespoons of dish washing liquid with water and apply liberally to all exposed surfaces. Rinse with clean water. DO NOT USE ABRASIVE OR SOLVENT TYPE MATERIALS OR PAINT REMOVER. THESE MATERIALS CAN SOFTEN, DULL, OR REMOVE THE BAKED ON ENAMEL FINISH!

To remove mildew

Black spots on the surface of your aluminum products may be caused by mildew. Watch carefully for rain protected areas such as the underside of your awning or enclosure roof. To eliminate mildew, purchase a product specifically designed for removal of mildew stains on painted surfaces.

Protecting the finish

A quality automotive wax can be applied to help preserve the factory finish on your aluminum products. Clean and dry surface and apply as per manufacturer's directions. Just as the finish on your automobile requires protection, your painted aluminum products will benefit from the same.

Use caution around sharp edges!

Be careful when cleaning any aluminum product, as there may sharp edges and corners which could cause harm. The use of protective gloves when cleaning aluminum products is recommended.

A.) Crest Aluminum (10) Year Limited Warranty

Roll formed aluminum 12" W panels, 8" flat panels, roll formed gutters, side fascia, generally utilized for end uses in patio covers, carports, screen rooms, (excluding decks) and roll formed awnings, and aluminum awning components such as sheets, tubes, valances, channels used on window awnings, canopies and patio covers and extruded aluminum parts and components either baked on or anodized such as decorative railing, extruded gutters, beams, posts, columns, and hanging rails used in the construction of its overall residential Products (the "Products") are warranted to you, the original owner named in this Certificate, by the Manufacturer, Crest Aluminum Products Company, Inc. Crest warrants against the Products containing manufacturing defects causing peeling, blistering, flaking, splitting, rusting, chipping, or cracking. The term "cracking" as used herein should not include minute fracturing of the Products which may occur during proper fabrication of the Products. The period of the warranty is ten (10) years beginning on the date the application of the Products to your property was completed. The warranty is subject to the conditions, remedies, prorations, limitations and legal rights stated in this Certificate. Steel and plastic Products are excluded from this warranty.

B.) Notice, Inspection, Remedies, Prorations & Conditions

1.) Notice and inspection.

If you think your Products contain manufacturing defects, write to Crest explaining your problem promptly after your discovery at:

Please do not begin any repairs prior to writing Crest, as Crest must have reasonable opportunity to inspect the Products for defects before repairs are begun.

2.) Remedies and Prorations

If your Products contain manufacturing defects, Crest will deliver to you, refinished, repaired, or new Products to remedy the defective Products on the following basis:

- a) During the first (5) years of the warranty period, you will receive refinished, repaired, or new Products without charge to remedy any defective part of the warranted Products.
- b) During the last (5) years of the warranty period, you will pay fifty percent (50%) of the then current wholesale cost to refinish, repair, or replace the defective Products.

3.) Conditions

All warranty claims shall be settled between you and Crest. Before Crest will refinish, repair, or replace defective Products, you must have (1) completely filled out the attached Registration Certificate, (2) had the form signed by your dealer, contractor, or installer, and (3) mailed the form to Crest Aluminum Products Company, Inc.

C.) Limitations

This warranty is not transferable. The warranty does not cover fading, staining, or chalking of any painted or anodized finish. This warranty does not apply to steel Products or plastic skylight panels. Normal weathering and aging of existing Products will preclude perfect color match of refinished or replaced Products. Crest reserves the right to discontinue and make changes in any of its Products. In the event the Products referred to in this warranty are not available, Crest shall have the right to substitute Products, that in Crest's discretion are of equal grade, quality, and price. Crest does not warrant against and shall not be liable for any damage to the Products when due to any causes, other than manufacturing defects, including but not limited to damage caused by faulty or improper installation or application of the Products or settlement, distortion, warping, failure, or cracking of the wall or to materials to which any of the Products are applied: earthquake, hurricane, tornado, cyclone, gale, lightning, fire, acts of God, flood, wind-borne objects, ice, hail, or weather of catastrophic nature as defined by the United States Weather Bureau, harmful chemicals, salt spray, fumes or vapors directly applied to the Products or in the atmosphere, vandalism, misuse, physical abuse, riot or insurrection or civil disorder, negligence, or failure to provide reasonable and necessary maintenance of the Products to prevent an accumulation of surface dirt, staining, or mildew.

Crest is giving you an express (10) year limited warranty under the provisions of the Magnuson-Moss Federal Warranty Act. As set forth in 15 USCS SECTION 2301 ET SEQ., Crest cannot and shall not be liable to you for breach of any other written or oral express warranties, such as those, if any, given to you by dealers, contractors, or distributors of awnings or canopies. ANY IMPLIED WARRANTIES IMPOSED BY LAW, SUCH AS THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR PURPOSE ARE LIMITED IN TIME TO THE DURATION OF THIS EXPRESS WARRANTY. CREST SHALL NOT BE LIABLE TO YOU FOR ANY CONSEQUENTIAL DAMAGES OR INCIDENTAL DAMAGES for breach of any express, written, oral or implied warranty on the Products. Your EXCLUSIVE REMEDY shall be repaired, refinished, or new Products only on the terms stated in this Certificate. Any claims do not extend the duration of the warranty.

D.) Legal Rights

Some states do not allow limitations on how long an implied warranty lasts, so the above limitation may not apply to you. Some states do not allow the exclusion or limitation of incidental or consequential damages, so the above limitation or exclusion may not apply to you. This warranty gives you specific legal rights, and you may also have other rights which vary from state to state.
